### Nonqualifying Synchronized Competition Judge Appointment Guidelines

General Comments	<ol style="list-style-type: none"> <li>A Nonqualifying Synchronized Competition appointment is <b>not</b> a pre-requisite to obtaining a Junior Sectional Synchronized Competition appointment.</li> <li>Judges with a Nonqualifying Synchronized Competition appointment should be actively working toward obtaining a Bronze Singles/Pairs Test appointment or Bronze Dance Test appointment, if they have not obtained one already.</li> <li>Judges with a Nonqualifying Synchronized Competition appointment are qualified to judge all levels of synchronized and showcase events at nonqualifying competitions as a one-judge minority of the panel.</li> <li>The Nonqualifying Synchronized Competition appointment is valid for 24 months and is not renewable.</li> </ol>
Criteria to Obtain Nonqualifying Synchronized Competition Appointment	Must be an eligible, reinstated or readmitted person in good standing as defined in Rule ER 1.00, a current member of U.S. Figure Skating and 18 years of age or older. A person 17 years of age may be appointed as a Nonqualifying Synchronized Competition Judge provided said person has been actively trial judging for a minimum of six months.
Guidelines to Obtain Nonqualifying Synchronized Competition Appointment	Candidates for Nonqualifying Synchronized Competition Judge must be recommended for the appointment by their home club and/or monitor. Nominations will be sent to the appropriate Sectional Vice Chair (RVC) for Synchronized Skating on the Judges Committee.
