**ELIGIBILITY:** This school is open to all judges and trial judges in ice dance. You must be at least 16 years of age for trial judging or 18 years of age for a judging appointment at the time of application and a current member of U.S. Figure Skating in good standing. You do NOT need to hold any judging appointments. Current members of the PSA in good standing may also attend. Coaches are welcome to attend the classroom portion from 9:00am-12:00pm. Those who attend the full school will receive 25 CEUs.
