## I. Opening of the Board of Directors Meeting

- A. Auxier called the meeting to order and welcomed everyone.
- B. Auxier confirmed attendance and a quorum.
- C. The agenda was adopted as proposed.
- D. Auxier asked the board members to disclose any conflicts based on tonight's agenda. No conflicts were disclosed.
- E. The April 30, 2025, minutes were approved as presented.

## II. President's Report

- A. Auxier welcomed the new Board Members and shared his optimism for the upcoming season.
- B. Auxier stated that he would share a document with the board regarding the standing rules of order for board meetings on Basecamp and discussed the expected conduct from board members.
- C. Auxier then welcomed Farrell to provide an update on his first three weeks as CEO.

## III. CEO's Report

- A. Farrell welcomed everyone and thanked Lundgren and Chang for their CEO Search Group efforts and thanked Auxier for being a great resource during his transition.
- B. Farrell shared that the first few weeks have been spent learning the details of headquarters and speaking with athletes in the field in order to identify areas of strength and improvement to have a strong Olympic year.

## V. Approval of RFAs related to Championship Events

A. O'Toole introduced Item 1: Addition of Novice Events at U.S. Championships. Change to include one group of Novice for pairs and ice dance at the 2026 Prevagen U.S. Figure Skating Championships. Auxier made the following motion:

**<MOTION>** to approve one group each of novice pairs and novice ice dance at U.S. Championships as presented. This action provides the following exceptions to rules 2502 and 2503.

#### **PAIRS**

Novice: maximum of 4 entries from the U.S. Pairs Final, top 4 teams from U.S. Pairs Final

Junior: 8 entries from the U.S. Pairs Final, top 8 teams from U.S. Pairs Final

IF any teams qualify for the ISU Junior Grand Prix Final of Figure Skating who are registered to compete junior domestically, they will receive a bye to the U.S. Championships (in addition to the 8 from the U.S. Pairs Final). If they withdraw prior to or at the U.S. Championships their byed spot will not be filled, as the maximum number of entries is 8.

#### ICE DANCE

**Novice:** maximum of 5 entries from the U.S. Ice Dance Final, top 5 teams from U.S. Ice Dance Final

Junior: 10 entries from the U.S. Ice Dance Final, top 10 teams from U.S. Ice Dance Final

IF any teams qualify for the ISU Junior Grand Prix Final of Figure Skating who are registered to compete junior domestically, they will receive a bye to the U.S. Championships (in addition to the 10 from the U.S. Ice Dance Final). If they withdraw prior to or at the U.S. Championships their byed spot will not be filled, as the maximum number of entries is 10.

## SECONDED. APPROVED.

B. Naphtal introduced Item 2: Modification of U.S. Championships Advancement Rules to Align with Bye Criteria. Change to include updates to 2501(B)(3), 2502(B)(3), and 2503(B)(3) to align with updates to the changes to the Olympic selection criteria. Goldstein provided further context behind the rationale. Naphtal made the following motion:

**<Request for Action>** to approve updates to rules 2501 (B)(3), 2502 (B)(3) and 2503 (B)(3) as presented. **SECONDED. APPROVED**. (Please see the corresponding report of action for specific language).

C. Naphtal introduced three items regarding changes to the Bye Criteria to ensure alignment with the rulebook. Naphtal proposed that the bye criteria be reviewed and voted on via e-ballot to allow time for some updates to the changes. There were no objections to this request.

### VIII. Release Policy

Goldstein shared that the Release Policy has been updated to read that skaters who competed in the Singles/Pairs/Ice Dance Discipline may reduce release timeline by one season should they reimburse U.S. Figure Skating for all financial support calculated by High Performance/CFO from the last four full seasons, and skaters who competed in the Synchronized Discipline may request an immediate release should they reimburse U.S. Figure Skating for all financial support allocated to the athlete calculated by the High Performance/CFO from the last four full seasons. McManus made the following motion:

MOTION: to approve the updated Release Policy. SECONDED. APPROVED.

If they withdraw prior to or at the U.S. Championships their byed spot will not be filled, as the maximum number of entries is 10.

## Modification of U.S. Championships Advancement Rules to Align with Bye Criteria

"3. Athletes who won a medal in the same event at the most recent any Olympic Winter Games (not including the team event)."
