Requirements/things to know:

- All participants **MUST** pre-register in order for the school to count for CEU for use in appointment application submission.
- Participants will access the course through emailed links.
- Participants are required to ask 1 question during the 2 sessions, either in chat or by raising hand and asking verbally after being unmuted by host.
- A quiz will be emailed to you at the end of the second session – questions will verify that you have watched the entire 4 hours of webinar. Quiz will be returned via email to JET (possibly a fillable quiz if we can get that set up in time). Quiz must be returned and completed successfully in order for school to count toward CEU or appointment use.
- Participants will receive 25 CEUs for this school.

ELIGIBILITY:

- This school is open to all levels of judges and trial judges in ice dance, but school is geared toward those working on Silver and Gold test appointments, and entry-level competition judging.
- You must
 - be at least 16 years of age for trial judging or 18 years of age at the time of application to use this school for a judging appointment requirement
 - be registered with US Figure Skating as a trial judge (or hold a current appointment if not actively dance trialing)
 - be a current member of U.S. Figure Skating in good standing
- You do **NOT** need to hold any judging appointments.
