Virtual Testing Reminders



- Virtual test sessions should be treated the same as an in-person session.
 - The test session should be announced with a registration date, and the test session date (note: video submission deadline set by the test chair is the test session date);
- Date of return of scores (no more than 7 days from date of test session);
- Videos must be date stamped 14 days prior to the test session date.
- Virtual testing is a CONTRACT between:
 - Skater/Coach
 - Host Club
 - Officials
 - Rule 4104
- Each entity must uphold their part of the CONTRACT for it to work and to maintain the integrity of the CONTRACT.

Virtual Testing Reminders



- . No more than 8 other skaters on the ice when recording video
 - . Other skaters cannot disrupt the performance
 - . Skater testing must be clearly identifiable
- . Limited background noise allowed for Skating Skills tests
 - . Singles, Pairs, Pattern Dance & Free Dance tests will have skater's music
- . No coaching during performance of test
 - . Exception: during brief breaks between elements in Skating Skills/ between partnered and solo portions of Pattern Dance

Virtual Testing Reminders



Review videos

- . Ensure quality is sufficient to send to judges
- . Meets video requirements (placard, followed by date/time stamp)
- . Reject videos that do not meet requirements

Confirm receipt of:

- . Performance Affidavits
- . Release and Consent documents

Transparent Communication

- . Don't use the BCC line to communicate with judges
- . All communication should be open
- . Reminder to send results back within 7 days
- . Share all docs (i.e., Affidavit and Media Release Forms)

Test Credit via IJS Protocol



- . After achievement, athletes have 14 days to provide the Test Credit forms to the Test Chair of their Home Club.
- . Athletes need to provide:
 - . A copy of the signed results (signed by both Event Referee and Technical Controller).
 - . A copy of their Protocol Sheet.
 - . A copy of the Test Credit result form from the Technical Accountant.
- . Test Chairs have 30 days from receipt of paperwork to report the results to U.S. Figure Skating
 - . Test Chairs should confirm the results pass; and
 - . There are no invalid elements (dashes) on the protocol sheet.
