Qualifications: Applicant must hold a minimum of a Bachelor's Degree from an accredited

University. A degree in education, social work, abuse counseling, psychology or relatable field is preferred, but not required. Applicant must have experience, confidence, and comfort in public speaking and curriculum building. Familiarity with the operation of youth sports clubs is beneficial, but not necessary. Applicant must be proficient in Microsoft Applications (Word, Excel, PowerPoint, Outlook), and Zoom. Applicant must have the ability to travel and work evening and weekend hours, when necessary. Relevant and measurable experience working with victims of abuse (sexual,

mental, and/or physical) is a plus.

Duties and responsibilities include, but are not limited to, the following:

- 1. Ability to learn and apply U.S. Figure Skating SafeSport Program rules and policies.
- Creates an educational curriculum focusing on SafeSport related topics for various member groups and age ranges.
- 3. Creates tools and resources for members regarding policy implementation, compliance, best practices, and other SafeSport related topics.
- 4. Presents live and pre-recorded webinars to various member groups on a regular basis.
- 5. Creates new avenues of engagement with SafeSport topics for parents, athletes, coaches, officials, club leadership, etc.
- 6. Works with various committees to ensure athlete input and safety are the cornerstone of all education and outreach.
- 7. Travels, as assigned, to give in-person SafeSport presentations to clubs, camps, and events to promote SafeSport education and awareness.
- 8. Consistently reviews and provides feedback on current processes, resources, and programs.
- 9. Works closely with SafeSport Compliance Specialist, Paralegal to communicate member compliance requirements.
- 10. Writes monthly magazine articles and newsletter blurbs based on relevant SafeSport content.
- 11. Collaborates with various departments and organizations to include SafeSport education and outreach at events, camps, seminars, etc.
- 12. Provides customer service to members regarding SafeSport compliance requirements and policy implementation.
- 13. Builds internal, cross-departmental, and external working relationships to increase visibility of the department.
- 14. Collaborates with Director, DEI to deliver education to members.
- 15. Collaborates with clubs across the country to implement various SafeSport education plans.
